1 | What documents we need

We are required to collect documentary evidence to support the source of any gift.

Here are examples of acceptable forms of documentary evidence.

<input checked="" type="checkbox"/>	Sale of investments	Statement from investment provider or bank statement showing settlement from investment provider.
<input checked="" type="checkbox"/>	Sale of property of Sale/ settlement statement	Signed letter from Solicitor / Advocate or Estate Agent or Contract
<input checked="" type="checkbox"/>	Loan	Loan agreement or statement.
<input checked="" type="checkbox"/>	Inheritance	Copy of will, signed letter from solicitor, Grant of Probate or letter from Executor.
